Hawaii	<p>Hawaii State-Approved Teacher Education Programs are required to meet one of the following requirements to be eligible for continuing state approval:</p> <ol style="list-style-type: none"> 1. Obtain continuing unit accreditation from the Council for Accreditation of Teacher Education (CAEP) or its legacy organizations (NCATE or TEAC); or 2. Submit official scores from the edTPA or the PPAT for all program completers recommended for licensure to the Hawaii Teacher Standards Board (HTSB), commencing no later than July 1, 2019. The edTPA or PPAT assessment will be one of a variety of assessments used by the EPP in deciding whether to recommend a candidate for licensure. Illinois	<p>Candidates applying for initial licensure in Illinois are required to pass an evidence-based assessment of teacher effectiveness. edTPA has been approved to satisfy this requirement for licensure.</p> <p>If a candidate completed the TPA as part of an educator preparation program in another state, and received a passing score in that state, Illinois will honor the score as passing in Illinois. South Carolina	<p>The South Carolina State Board of Education has adopted edTPA as a performance-based assessment option for educator preparation providers to implement with teacher candidates within their approved teacher preparation programs. edTPA will measure candidates' knowledge and skills as they pursue educator preparation program completion and/or apply for an initial teaching certificate in the State of South Carolina.</p> <p>Passing edTPA will be an option effective January 1, 2018, for teacher candidates completing state-approved educator preparation programs to meet the required pedagogy assessment for issuance of a South Carolina initial teaching certificate by the South Carolina Department of Education (SCDE).
